The purpose of this meeting is to hear interested parties and citizens on a request by the applicant, Tyler Sallee, on behalf of the property owner, Sallee Homes Inc., to approve an amendment to the Adams Pointe Village Planned Residential Overlay (PR-O) Concept Plan on property generally located at 2610 East R.D.
