

**Blue Springs Municipal Court**

**Revised Violation Bureau Fees**

March 13, 2017

The Blue Springs Municipal Court, by authority of the Missouri Supreme Court Rule 37.49, does establish this Violation Bureau, subject to the supervision of the Jackson County Circuit Court and does designate the Court Administrator and Court Clerks of the City of Blue Springs to accept appearance, waiver of trial, plea of guilty, and payment of fine and costs for the designated violations and to enter the pleas on the record and transmit the violation record as required by law.

The violations within the authority of the bureau shall be designed by the order of the Judge and may be amended from time to time.

No violation resulting in personal injury or property damage shall be disposed of through the Violation Bureau, nor shall any violation involving drugs or alcohol be disposed of.

No speeding violation occurring in a school or construction zone shall be disposed of through the Violation Bureau.

The following violations may be disposed of through the Violation Bureau with the fines and costs to be imposed upon a plea of guilty specified below. The amount shown includes fines and court costs.
