Under city ordinance, no one with a felony conviction may hold an Employee Liquor Permit. A suspended imposition of sentence is not a felony conviction. Applicants currently under SIS must provide a letter signed by a Probation Officer stating that (s)he knows of the applicant's desire to obtain a liquor card. The probation officer may submit this letter directly to the Blue Springs Police Department by faxing to (816) 228-0268. If otherwise qualified, the applicant will be granted a liquor card for the duration of the successful SIS or two years; whichever is shorter.

All applicants must be authorized to work in the United States and at the time of application, must present positive proof of identification in the form of a state issued Driver's License or ID Card, US Passport, Permanent Resident Card, Employment Authorization Card, Military ID Card or other approved form of identification. Fake, false or altered identification cards will be confiscated.
