Notice is hereby given that a public hearing will be held by the Planning Commission of the City of Blue Springs on **Monday, February, 28, 2022 at 6:30 p.m.** in the Council Chambers of the Howard L. Brown Public Safety Facility at 1100 SW Smith Street for the purpose of hearing interested parties and citizens on a request by the applicant and property owner, Nate Anderson with Lakeview Center Holdings, to rezone property from “GB/PUD” (General Business/Planned Unit Development) to “LI/PUD” (Light Industrial/Planned Unit Development) at 2309, 2401, & 2505 SW 40 Hwy. and generally located at the northeast corner of SW 40 Hwy. and SW Cemetery Rd. ALL THAT PART OF THE COMPLETE AUTO REPAIR SERVICES CENTER, A COMMERCIAL P.U.D.
