PSST FINANCIAL REPORT:

Chief Muenz presented the cumulative report regarding The Public Safety Sales Tax monthly financial statement for month ending of January 31, 2022.

The 1/2% Public Safety sales tax is imposed on all taxable goods and services within the City limits of Blue Springs and can only be used for public safety purposes. The tax went into effect on October 1, 2011. The detailed budget for the Public Safety Sales Tax Fund can be found on page 72 of the 2021-22 adopted budget. For the month of January, the City received 98% of budgeted revenues and 111% of revenue received last year. For the fiscal year, PSST sales tax revenues are \$118,557 or 9% over budget.

Board members had discussion regarding financials and approved purchases. Chief advised the board that moving forward, the financials will be dated one month behind. Board spoke about rising fuel costs, helmets, retention payment, step program, FOP, CALEA and animal control. Board member Stacer moved to approve the PSST Financial reports.
